Sir/Madam,

This has reference to the proposal submitted by Amritsar College of Engineering and Technology, 12Km Stone Amritsar Jalandhar GT Road, Amritsar-143 001 affiliated to IKG Punjab Technical University, Kapurthala for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

As per the decision of the Standing Committee constituted by University Grants Commission, in its meeting held on 01.09.2021, the Competent Authority has decided to extend the autonomous status to **Amritsar College of Engineering and Technology, 12Km Stone Amritsar Jalandhar GT Road, Amritsar-143 001 affiliated to IKG Punjab Technical University, Kapurthala** for a period of Five (05) years from the session 2021-2022 to 2025-2026 Including ex-post-facto approval for the period 2020-2021 as per provisions of Clause 3.13 and Clause 6.3 of UGC Regulations dated 12.02.2018.

The University is requested to issue necessary notification/order regarding extension of autonomous status to the College as per the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The College, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The Autonomous College is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugu.ac.in. Non compliance of the requirements and conditions in the said Regulations shall attract action as per Clause -14 of the UGC Regulations - 2018. Further, it may be noted that the above said college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.



This has reference to the proposal dated 06.04.2013 submitted by Amritsar College of Engineering & Technology 12 Km Stone, Amritsar, Jalandhar G.T. Road, Amritsar – 143 001 Punjab affiliated to Punjab Technical University, Punjab under the UGC scheme for conferment of fresh autonomous status and subsequent visit of the UGC Expert committee to consider the proposal on 18th & 19th November, 2013 and this office letter dated 20.01.2014.

The report of the aforesaid Joint UGC Expert Committee was placed before the Standing Committee constituted for the purposes by the Commission to look into the Expert Committee reports for conferment of fresh autonomous status and extension of autonomy to colleges before its recommendations are placed before the Commission for its final approval.

The recommendations of the Standing Committee were placed before the Commission at its meeting held on 13.06.2014. The Commission, after taking due consideration of the recommendations of the Standing Committee, agreed to grant autonomous status to Amritsar College of Engineering & Technology 12 Km Stone, Amritsar, Jalandhar G.T. Road, Amritsar – 143 001 Punjab under the UGC autonomous colleges scheme for a period of six year w.e.f. the academic year i.e. 2014-2015 to 2019-2020.

The Punjab Technical University, Punjab may now go ahead and issue necessary orders in this regard by endorsing a copy of the same to this office for our records. The admissible grant under this scheme will be released to the College as per its eligibility, according to the norms as laid down in the XII Plan Guidelines for Autonomous Colleges by the Joint Secretary, Northern Region College Bureau (NRCB) UGC, 35, Feroze Shah Road, Mandi House New Delhi – 110 001.
