D. Term and Termination:

J. **Governing Law**

This MoU shall be governed by the laws of India and the courts at New Delhi shall have the exclusive jurisdiction over all the disputes relating to or arising out of this MoU.

K. **Entire Agreement**

This MoU represents the entire understandings between the Parties concerning the subject matter prescribed hereof and shall supersede all prior or simultaneous communication, representations, discussions, negotiation, and agreements, either written or oral, existing, or proposed.

L. **Amendment and Assignment**

- 1. This MoU may only be amended, modified, altered only by an instrument in writing, expressly referring to this MoU and signed by both the Parties.
- 2. Neither Party may assign any of its rights or delegate any of its duties under this MoU without the prior written consent of other Party except that either Party may assign this MoU to successor-in-interest-in connection with the sale of all or substantially all of its assets.

M. Waiver

The failure of either Party to enforce at any time or for any period of time the provision hereof in accordance with its term shall not be construed to be a waiver of such provision or rights of such Party thereafter to enforce each and such provision. A waiver shall not be valid and effective unless the same is in writing.

N. Relationship of Parties

Nothing herein shall constitute a partnership between the Parties and neither Party shall hold itself as an agent of the other Party.
