Sub: Withdrawal the status of 12 (B) of the College.

Sir,

While preparing the list of Colleges under Section 2 (f) and 12 (B) of the UGC Act, 1956. It has come into the notice that the name of "Amritsar College of Engineering & Technology, 12 k.m. Stone, Amritsar Jalandhar, G.T. Road, Amritsar - 143 001, Punjab" inadvertently included under Section 12 (B) of the UGC Act, 1956 but the said College is not eligible to include under Section 12 (B) of the UGC Act, 1956, according to the provision made in the University Grants Commission (Fitness of Institutions for grant Rules, 1975) as the affiliating University of the said College is not covered under Section 12 (B) of the UGC Act, 1956.

Therefore, the UGC, after due consideration has decided to **withdraw the 12 (B) status** granted to **Amritsar College of Engineering & Technology, 12 k.m. Stone, Amritsar Jalandhar, G.T. Road, Amritsar - 143 001, Punjab**. Now, the college is included only under Section 2 (f) of the UGC Act, 1956.

Inconvenience caused to the University and the College is deeply regretted. The College may again apply for the 12 (B) status whenever it will be eligible.
