




NOW THERERFORE, THESE PRESENTS WITNESSES AS FOLLOWS:

Purpose:

The purpose of this MOU is to establish a collaborative partnership between **Amritsar Group of Colleges** and **Cake A Licious** to provide certified baking courses and programs to students and professionals, thereby enhancing their skills, knowledge and employability in the field of bakery and culinary arts. AGC will issue certificates of completion to students who successfully complete the courses offered by **Cake A Licious**.

Objectives

- To provide the practical training to the students as per the industry standards.
- To enhance the curriculum of BHMCT and B.Voc.(HCM) courses by integrating hands-on experience and expertise from Cake A Licious.
- To facilitate the exchange of knowledge, resources, and best practices between the Parties.
- To ensure the curriculum aligns with industry standards and requirements.

Terms and Conditions:**1. Responsibilities of Amritsar Group of Colleges (AGC):**

- AGC will assist in the promotion of the baking program offered by Cake A Licious.
- AGC will motivate and encourage students to enroll in the baking course.
- The regular inspections will be carried out by the AGC officials during the training period.
- AGC will have the right to incorporate the changes/amendments as per requirement.
- AGC will ensure that students will deposit the fees before the commencement of the course.
- Training provision will be provided to the students who will be in BHMCT (4th & 8th Sem) and B.Voc(HCM) (4th & 6th Sem).
- AGC will conduct the final examination at the completion of course.

2. Responsibilities of Cake A Licious:

- Designing and delivering the baking courses and programs as per the required standards and curriculum.
- Maintaining a high standard of teaching and also ensure that the participants will perform as per required standards of the industry.
- Maintaining the proper attendance record of the students which will be shared by them during the visit of AGC officials & completion of the course.

3. Duration of the MOU:

5. Confidentiality:


Both parties agree to maintain the confidentiality of any proprietary or confidential information shared during the course of this MOU.

6. Amendments:


Any amendments or modifications to this MOU must be made in writing and signed by authorized representatives of both parties.






