## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (MoU) is executed on the Fourth day of August 2025 between Amritsar Group of Colleges, functioning under Amritsar International Foundation Trust and located at 12 km stone, Amritsar-Jalandhar GT. Road, Amritsar 143001, represented by its Principal

Preet Hospital the premier health and care Institute, located at Rattan Singh, Chowk Fatehgarh Churian Road, Amritsar, Punjab 143001, represented by Dr. Jaspreet Grover

### **Article 1: Purpose of the Agreement**

- i. Amritsar Group of Colleges, Amritsar established in 2002, is a reputed college of higher education in the state, serving the cause of National development by offering tertiary education and conducting basic and applied research in various disciplines.
- ii. Preet Hospital, Rattan Singh, Chowk, Fatehgarh Churian Road, Amritsar, is a modern health care Institute, equipped with ultra modern state-of-the-art facilities and is implementing latest treatment techniques in the service of human health care.
- iii. Collaboration for teaching of relevant portions of the courses and for conducting structured residency (Internship)/ field training /Sonography practicing is essential for Radiology and Imaging Technology, Operation Theatre Technology, Medical Lab Sciences programmes of Amritsar Group of Colleges where course work are related to Medical Sciences/ Allied & Healthcare Specializations, for this purpose a MoU with an established institution like Preet Hospital is envisioned.
- iv. Amritsar Group of Colleges and Preet Hospital have mutually agreed to collaborate in the teaching, conducting practicals in relevant courses and for providing required residency/field training/ attachment program for various courses related to Medical Sciences/ Allied & Healthcare

### **Article 2: Implementation of the MoU**

- i. The work related to the academic instructions required for various Medical Sciences/ Allied & Healthcare Specializations related courses will be conducted in relevant Departments of Amritsar Group of Colleges/ Preet Hospital.
- ii. Preet Hospital agrees to extend its facilities for conducting the practical exams as well as residency/field training/workshops/attachments etc. free of cost.

### **Article 3: Restrictions and Limitations**

- i. This agreement is not to be construed as contract in law, creating legal relationship between the two institutions. Instead, it is formulated in the interest of generating human resource in the field of Medical Sciences/ Allied & Healthcare Specializations to facilitate and develop mutually beneficial synergistic academic activity.
- ii. In the spirit of this agreement, each institution is considered as principle. Neither institution is authorized or empowered to act as agent for the others for any purpose or shall enter on behalf of the others into any contract or representation on any matter. None of the two institutions shall be bound by the acts or conduct of the other.

### **Article 4: Validity of the Agreement**

- i. This agreement between the Amritsar Group of Colleges and Preet Hospital is valid for Five Years as per mutual agreement.
- ii. For incorporating any modification, changes and amendments to this MOU, the written consent from both the Institutions-Amritsar Group of Colleges, Amritsar and Preet Hospital Rattan Singh, chowk Fatehgarh Churian Road, Amritsar shall be mandatory.
