

**Amritsar Group of Colleges, Amritsar, Punjab** represented by Dr. Gaurav Tejpal (Principal), having its office at 12 km Stone, Amritsar-Jalandhar G.T. Road, Amritsar-143001, which term shall, unless repugnant to the context or meaning thereof, be referred to as the **PARTY OF THE SECOND PART / AGC.**

**PURPOSE**

This MoU aims to establish a collaborative framework between **Ramada Encore by Wyndham, Amritsar** and **Amritsar Group of Colleges** to enhance skill development, professional exposure, and employability of Hospitality & Hotel Management students.

The primary objectives include:

- a. Bridging the academia-industry gap in the hospitality sector through structured training initiatives.
- b. Facilitating six-week internships and six-month industrial training for eligible Hotel Management students as per curriculum requirements.
- c. Organizing expert lectures, hospitality workshops, skill development sessions, and hotel operations seminars by professionals from Ramada Encore.
- d. Supporting campus placements and providing career opportunities in hotel operations, food production, F&B service, front office, and housekeeping.
- e. Promoting faculty-industry engagement to align teaching pedagogy with the latest hotel industry practices.
- f. Collaborating on emerging trends such as digital hospitality, guest experience management, and sustainable hotel operations.
- g. Facilitating industrial visits to Ramada Encore's property and operational facilities for hands-on exposure.

## Clause 1: CO-OPERATION

- Food & Beverage Service
- Food Production & Culinary Operations
- Guest Handling & Customer Service Skills
- Hotel Software (PMS) Exposure
- Safety, Hygiene, and Quality Standards

2.2 Ramada Encore by Wyndham, Amritsar will guide, assess and provide performance feedback for students during training.

2.3 AGC will nominate eligible students and coordinate academic requirements.

2.4 Ramada Encore by Wyndham, Amritsar will extend support in identifying placement opportunities for deserving students.

2.5 Joint collaboration in hospitality research, guest experience enhancement and service quality improvement.

2.6 Joint conduct of events such as culinary competitions, hospitality exhibitions, live demonstrations, etc.

## 3: ROLES AND RESPONSIBILITIES

### 3.1 Ramada Encore by Wyndham, Amritsar

- Provide industrial training & job training in hotel operations.
- Conduct expert sessions, workshops, and skill-based demonstrations.
- Participate in campus placements and hire suitable candidates.
- Facilitate hotel tours and operational exposure visits.
- Mentor students on guest services, service standards, culinary basics, and hotel management practices.
- Collaborate on sustainable hospitality initiatives and guest experience enhancement.

### 3.2 Amritsar Group of Colleges (AGC)

- Prepare students with foundational hospitality knowledge.
- Nominate trainees and monitor their performance.
- Facilitate faculty interactions with industry professionals.
- Maintain updated profiles for placement coordination.

### 4.3 Indemnification

- Each party shall be responsible for liabilities arising from its own operations.

### 4.4 Force Majeure

- Neither party shall be held liable for delays due to circumstances beyond reasonable control.

### 4.5 Termination

- Either party may terminate the MoU with **one month's written notice**, subject to fulfilling ongoing commitments.

### 4.6 Dispute Resolution

- Any dispute shall be resolved amicably through discussion between designated coordinators.

### 4.7 Variation

- Any modification must be mutually agreed upon in writing and signed by both parties.

### 4.8 General Provisions

- Both parties will appoint a coordinator to monitor progress.
- This MoU establishes a collaboration and does not create any legal partnership.


