

Policy regarding fee payment for DRCC Cases (Jan-2024 onwards)

Semester	Eligibility criteria for appearing in final examination
1 st	<ul style="list-style-type: none">DRCC case must be applied and self-component is paid
2 nd	<ul style="list-style-type: none">1st semester fee from DRCC must be received and self-component is paidDRCC case must be active
3 rd	<ul style="list-style-type: none">Upto 2nd semester fee from DRCC must be received and self-component is paidDRCC case must be activeIn case of violation of any condition, with active case student has to pay 2nd semester academic fees
4 th	<ul style="list-style-type: none">Upto 3rd semester fee from DRCC must be received and self-component is paidDRCC case must be activeIn case of violation of any condition, with active case student has to pay 3rd semester academic fees
5 th	<ul style="list-style-type: none">Upto 4th semester fee from DRCC must be received and self-component is paidDRCC case must be activeIn case of violation of any condition, with active case student has to pay 4th semester academic fees
6 th	<ul style="list-style-type: none">Upto 5th semester fee from DRCC must be received and self-component is paidDRCC case must be activeIn case of violation of any condition, with active case student has to pay 5th semester academic fees
7 th	<ul style="list-style-type: none">Upto 6th semester fee from DRCC must be received and self-component is paidDRCC case must be activeIn case of violation of any condition, with active case student has to pay 6th semester academic fees
Final semester of any branch (4 th , 6 th , or 8 th)	<ul style="list-style-type: none">Student must have cleared full fee and other dues in case of rejectionIn case of violation of any condition, with active case student has to pay 7th semester academic fees

If a case is different from the above-mentioned conditions that must be referred to accounts branch for clarification.
