1. Review of Recent Disciplinary Incidents

• **Discussion:**

The committee reviewed reports of recent disciplinary incidents, including violation of hostel rules, instances of late-night entries, and disturbances caused by loud music. It was noted that the frequency of such incidents had increased, particularly over weekends.

• **Decision:**

The committee decided to impose stricter penalties for repeated violations and recommended that wardens reinforce curfew and conduct frequent inspections. Notices will also be issued to residents as a reminder of the rules.

2. Actions on Previous Complaints (if any)

• **Discussion:**

Previous complaints regarding unauthorized visitors and misuse of common areas were revisited. It was confirmed that fines had been imposed on the responsible students, and actions were taken to restrict visitor access during curfew hours.

• **Decision:**

The committee agreed that additional monitoring is necessary to prevent the recurrence of such incidents. CCTV coverage will be increased, and visitors' logbooks will be reviewed regularly.

3. Discussion on Surprise Visits to the Hostel (Boys' and Girls' Hostel)

• **Discussion:**

The committee discussed the proposal for surprise inspections in both boys' and girls' hostels. It was noted that surprise visits could help ensure compliance with hostel rules, especially with regard to curfew and room cleanliness.

• **Decision:**

The committee approved the implementation of surprise visits, which will be conducted by wardens and committee members on a rotational basis. The visits will be unannounced, and the results will be reported at the next meeting.

4. Discussion on Leave from Hostel

• **Discussion:**


Concerns were raised about the process of students taking leave from the hostel, as some students were found to be leaving without proper authorization.

• **Decision:**

The committee decided that all students must submit a written request to the warden for approval before taking leave. Parents will also be notified of any overnight leaves. A stricter policy will be enforced, and students failing to comply will face disciplinary action.
