Proceedings:

- 75.3.2 It was further noted that the duplication arose due to the same question bank content uploaded for both Questions 13 and 14. The committee decided to issue an advisory to the concerned paper setter, instructing strict adherence to question uploading protocols as per the prescribed guidelines.
- 75.3.3 The members advised that the paper setter should make the necessary changes in the question bank, and the HoD shall ensure its implementation.

Reforms to be submitted to Dean Academics for the 16th Meeting of Academic Council
