




The 30th Meeting of the Library Committee was held on 18th February 2025 at 11:30 AM in the Training & Placement Cell. The Member Secretary welcomed all the committee members and initiated the discussion regarding the finalization of e-journal subscriptions. Various proposals were presented by the Member Secretary and members were invited to engage in discussion and mutual deliberation on the same, as detailed below:

1. IETE Journals (Print & Electronic)

- 1.1 The members proposed subscribing to the IETE Journal of Research and the IETE Technical Review.
- 1.2 The annual subscription cost for this combo of two journals is Rs. 15,000/-.
- 1.3 It was informed that a 10% discount is applicable on subscribing for three years. Accordingly, the members unanimously agreed to opt for the three-year subscription, which will cost **Rs. 40,500/-**. *We shall pursue it*

2. IEEE e-Journals

- 2.1 The members reviewed both proposals — ASPP (All Society Periodicals Package) and CSDL (Computer Society Digital Library) — and decided to opt for the ASPP, which provides access to 217 e-journals.
- 2.2 The annual subscription cost for the ASPP package is **Rs. 6,69,196/-**.




3. Online journals by ICT Academy


Dr. Narinder Sharma, Dean R&D, proposed the subscription of six online journals from the ICT Academy. The proposal also includes additional benefits such as two Faculty Development Programmes (FDPs) to be organized on our campus each year along with several other academic and professional advantages.

The members appreciated the proposal and unanimously agreed to opt for the ICT Academy membership, which will cost **Rs. 59,000/- per year**.

4. INFLIBNET- NLIST

The INFLIBNET (N-LIST) proposal was reviewed. It was found that our institution is not eligible for the subscription, as it does not fall under Section (B) of the eligibility criteria.





Additionally, the e-content offered under this proposal does not cover the disciplines of Engineering, Pharmacy, and Management.

In light of these limitations, the members decided to drop the proposal for further consideration.
