Functions of the Committee:

- To prohibit, prevent and eliminate the source of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- To prohibit undisciplined activities by any student or students this causes or is likely to cause hardship or psychological harm or to raise fear in any fresher.
- To decide various anti-ragging measures/awareness as per the guidelines of UGC/ AICTE/ PCI/ IKGPTU/ PSBTE&IT and as per the directive of the Hon' Supreme Court of the country.
- To address 1st year students in the college as well as hostels to make them aware of Anti-Ragging measures initiated at AGC Amritsar.
- To form and coordinate with anti-ragging squad to curb the menace of ragging.
- To counsel senior students not to indulge in the ragging activities.
- To create the awareness about Anti Ragging act and punishments among the students and the appropriate law in force.

Duration of the Committee: Two Years

Meetings Schedule: At least two meetings in a year. In case of emergency, meeting can be called.

Record maintained by: Convener/Member Secretary of the committee.


